





Created in 2011 to provide science-based professional advice to EU national and regional policy-makers for the establishment and implementation of their Research & Innovation Strategies for Smart Specialisation (RIS3), to make better use of the European Structural and Investment Funds (ESIF) and thus contribute to the Europe 2020 goals.

DG JRC - DG CONNECT Collaboration on DIH and Smart Specialisation

- Online tool JRC B3 develops an online tool that visualises a catalogue of Digital Innovation Hubs in a searchable map/database. The tool is hosted in the Smart Specialisation webpage. Data gathered by a TNO led consortia
- 2. Case studies identifying, documenting and diffusing good practices of DIH involved in developing and implementing Smart Specialisation Strategies, also mobilising a community of practitioners in collaboration.
- 3. Mapping and analysis of DIH collaboration patterns; analyse DIH networks of collaboration based on the catalogue of DIHs. Both on a regional and European level, possible data, FP7 and H2020, patents, and social media.
- 4. Case studies of DIH strategies depending on socio economic contexts. Based on the other packages a selected number of regions will be explored in more depth.




