



- 1. In the EU innovation programmes are funded by 90% from national public funds and
 - 10% from public intenational funds of which
 - 8 % coming from H2020
 - 2% from EUREKA
- 2. EUROSTARS is a partially funded by H2020 framework programme implemented by EUREKA Secretariat
- Some countries lacking of pubic funds have financed in the past Eurostars projects with Regional Funds (Estonia).
