

RDI strategy 2014-2020

- Reinforce, with the help of European Union Structural Funds and activities financed from the state budget, the capacity of Estonian research institutions to participate in forms of cooperation based on quality competition, incl. in the programme "Horizon 2020".
- ...it is important to achieve a closer connection with the initiatives of the European Research Area (incl. joint programming of research, European innovation partnership, initiatives of the common area of the Baltic and Nordic countries) and to participate in pan-European RD infrastructures. To enhance domestic research and development, it is also important to use the potential of the European Union research and innovation framework programme "Horizon 2020".

Synergies in the Estonian OP

- In addition, R&D-related activities will support the institutional reforms of universities and R&D institutions, high level research, international cooperation (incl. synergy with the EU 'Horizon 2020' Research and Innovation Framework Programme), the mobility of students, university teachers and researchers, and the emergence of their next generation (OP, p9)
- As regards international research cooperation, priority will be given to investments that will enhance Estonia's participation and visibility in international research cooperation and leverage synergy between the objectives of the Structural Funds and Horizon 2020, while avoiding potential overlaps. (OP, p91)

- 2 Estonian projects:
 - ITEE
 - FINEST TWINS

- Support for infrastructure and equipment
- Support for human capital, internationalisation and business cooperation
- Directly linked to smart specialisation
- + national long-term commitment needed to ensure sustainability

. ERA Chairs

Currently Estonia holds 3 ERA
Chairs from H2020 and 1 from
FP7

- Support for research costs and equipment that is not covered by the H2020
- Support from Mobilitas Pluss up to 200 000 € per project



European Research Council

Horizon 2020

Excellent Science

European Research Council grants

- Support for re-application for researchers who achieve high results in ERC evaluation, but who do not receive a positive financing decision (in the amount of national personal grant up to 100 000 € per year, for up to 1,5 years)
- Trainings and study visits for researchers (to prepare for a successful application)



ERA NET support

Horizon 2020

ERA-NET projects

- Support for participation in the ERA-NET calls, which are not financed by the European Commission
- Support from Mobilitas Pluss is up to 150 000 € per project



EIT - KIC

Horizon 2020

European Institute of Innovation and Technology (EIT)

Knowledge and Innovation Communities (KICs)

- Support for costs that are not covered by the H2020
- Support from Mobilitas Pluss is up to 60 000 € per project



SOME PRACTICAL EXAMPLES FROM NATIONAL FUNDING

Support for application preparation

- Support for preparing successful applications to Horizon 2020
- Evaluaton result must be above treshold in H2020
 - Support for coordinators: 3 600 €
 - Support for individual projects: 2 400 €
 - Support for project partner (WP leader): 1 200 €
 - Baltic Bonus: 1 000 € (extra bonus if LV or LT partners are involved)


Total grant revenue from framework programmes

National funding

- In the base-line funding for Estonian research institutions since 2005 the revenue from FP-s has been taken into account in the national funding formula - institutions get awarded for FP revenues.
- Funding formula:
- **50%** research revenue from abroad and business sector contract research
- 40% scientific publications
- 10% Nr of defended PhD degrees

CURRENT RESULTS

Revenue from Horizon 2020 – per capita and per GDP, % of EU average (EU28 = 100%)

Challenges for synergies

- Different state aid regulations for H2020 and SF
- Different financial regulations (cost models)
- Different selection criteria
 - H2020 is open to all domains \rightarrow SF is focused on smart specialisation.
 - SF has certain obligatory selection criteria
- Different funding opportunities (size of grants)
- International partners in the project
 - SF has limits for funding partners outside the programme region

Conclusion

- There are good examples where synergy works (H2020 and SF complement each ohter)
- But in Estonia there are no good examples where replacement works

- → Synergies are about complementarity between H2020 and SF, not replacement
- It takes two to tango...
