

- facilitate the refinement & implementation of RIS3 strategy in REMTh
- serve as a model for other convergence regions in Greece and Europe

- September 2014 November 2015
- Carried out by EC-JRC-IPTS through administrative agreement with DG REGIO, in close cooperation with the Managing Authority of REMTh, the Regional Council for Innovation and Entrepreneurship and with the support of experts, including "critical friends"

#### ENTREPRENEURIAL DISCOVERY PROCESS

- Two set of events: engage and prepare stakeholders for RIS3 implementation
  - EDP Focus groups generation of project-ideas on key sectors
  - Project Development Labs further development of ideas

- R&D Funding Guide
- Working group on human resources and mobility
- Working group on governance







#### **1. EDP Focus groups**

- Three IPTS-led Entrepreneurial Discovery Focus Groups:
  - Wine 11/14, Meat and Dairy 1/15, Tourism 2/15
  - Capacity building: 4th focus group on marble and zeolite organised by the region
  - Very high participation of stakeholders
- Interactive participatory methodology involving national and international experts. Key principles:
  - Understand local strenghts
  - Local, national or international networks/partnerships (e.g. halal meat value chain)
  - Now focus on the idea not on the money



### 2. In-depth peer review

- Exclusive focus on REMTh (Feb. 2015)
- High national and international participation
- Issues discussed:
  - Monitoring and evaluation
  - RIS3 Implementation
  - State Aid
  - RIS3 Governance
  - Human resources mobility and training
- Political relevance: Mr Piper and Governor.
- Media coverage: local and German TV
