Since January 2012, the Platform has organized 5 Peer Review Workshops for registered regions. 81 regional / national administrations have participated at least once to a peer-review, of which 28 regions have participated more than once. Around 260 policy-makers and experts have attended the workshops so far. Including the next February rendez-vous in Palma de Mallorca, 24 EU regions will have had their strategy peer-reviewed.

S3 GOES DIGITAL !

The Europe 2020 strategy has recognised the enormous potential and enabling role of ICT and made the Digital Agenda for Europe (DAE) one of its seven flagships. Its aim is to deliver smart, sustainable and inclusive economic growth through the realisation of the digital single market and the exploitation of the potentials for innovation of fast and ultra-fast internet and interoperable services and applications.

The development of a chapter for digital growth within their RIS3 will enable regions to identify the priorities for ICT investment relevant to their specific territory, balancing the needs between offer and demand for ICT infrastructure, applications and services. ICT uptake and innovative applications indeed can play a crucial role in the context of the RIS3 priority setting exercise and the identification of future areas of specialisation.

The S3 Platform, together with DG CONNECT and in co-operation with DG REGIO, is going to integrate the DAE perspectives and challenges into its activities in 2013 and onwards. The aim of this initiative is to provide support to national and regional policy makers to successfully develop and implement ICT-based innovation in their RIS3 and related EU cohesion policy operational programmes (OP). More detailed information will be made available in the next issues of this Newsletter.

S3 FOCUS – REGIOSTARS AWARDS 2014

The objective of the **RegioStars Awards** is to identify good practices in regional development and to highlight original and innovative projects which could be attractive and inspiring to other regions. The RegioStars awards form part of the Commission's Regions for Economic Change initiative, which aims to highlight good practice in urban and regional development.

The application process for the 2014 RegioStars Awards is now open.

Applications should be sent **by 19 April 2013** to the electronic address REGIO-STARS@ec.europa.eu. The selected finalists will have the opportunity to showcase their projects before an independent jury during the eleventh annual European Week of Regions and Cities - OPEN DAYS 2013. The Award ceremony itself will take place in Brussels in early 2014.

There are **five RegioStars Award categories** for 2014:

1. SMART GROWTH: SME innovation
2. SUSTAINABLE GROWTH: Green growth and jobs through Bio-economy
3. INCLUSIVE GROWTH: Creating jobs for the young generation
4. CITYSTAR CATEGORY: Investment projects in sustainable urban public transport
5. MAJOR INVESTMENT PROJECTS: Energy efficiency and the low carbon economy
