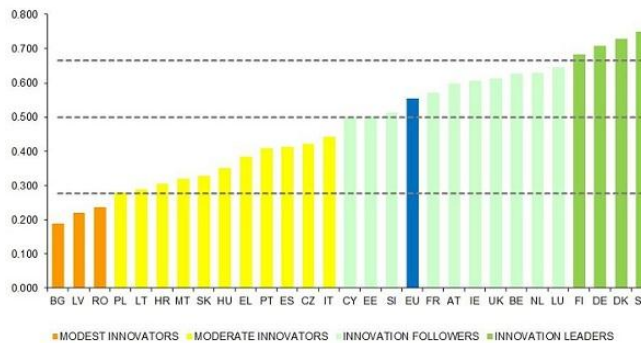
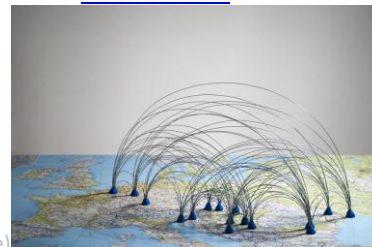


Figure 1: Innovation Union Scoreboard, 2014
