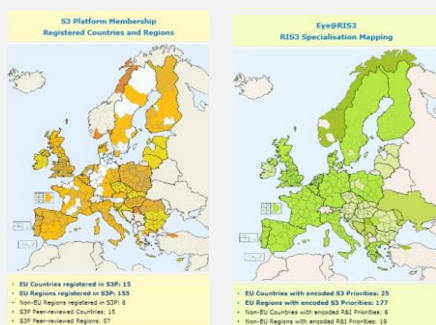

### GUIDE (DG GROW): FOSTERING SME GROWTH THROUGH DIGITAL TRANSFORMATION"

This [guide](#) is addressed to national, regional and local stakeholders interested in promoting regional innovation and competitiveness through the use of information and communications technology (ICT), with a special focus on small and medium sized enterprises (SMEs). It introduces an EU initiative which aims to improve the framework conditions for the smart use of ICT in specific sectors and offers suggestions on how the results of these initiatives could be exploited by follow-up actions in other regions, to further advance the smart use of ICT in Europe. It should be of interest to all regions, in particular regions with a strong base in agriculture & food, textile & clothing, automotive, transport & logistics, tourism or construction as these sectors were covered by the six projects under the EU initiative. ### LAUNCH EVENT OF THE EUROPEAN SMART SPECIALISATION PLATFORM ON ENERGY (S3P –ENERGY)

A high-level conference launched in Brussels on the 26 May 2015 the joint initiative of the Directorates-General for Regional and Urban Policy, Energy, and the Joint Research Centre (JRC) to set up a platform on smart specialisation on energy. The European Smart Specialisation Platform on Energy is planned to become an enabling tool for regions to coordinate, rationalise and plan their respective energy strategies, develop a shared vision on knowledge-based energy policy development in regions, and set up a strategic agenda of collaborative work in the frame of the Smart Specialisation Platform which will foster the identification and deployment of innovative practices in the renewable energy sources and energy efficiency.
