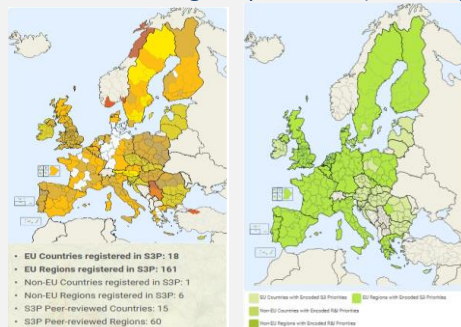

28-29/01/2016, SEVILLE, SPAIN

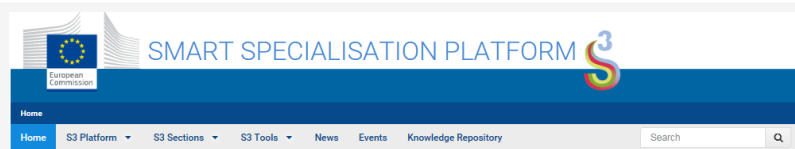
**REGISTRATION NOW OPEN - DEADLINE ON 08/01/16!**

### THE INNOVATION ADOPTION GAP, 16-17/12/2015, GENEVA, SWITZERLAND

The S3 Platform participated to the UN Team of Specialists on Innovation and Competitiveness Policies meeting in Geneva on 16-17 December 2015. The group is to focus on 'The Innovation Adoption Gap: Strategies and Policy Options for Accelerating the Adoption and Diffusion of Innovations'. This applied policy seminar is expected to lay the groundwork for developing good practices and policy recommendations for addressing gaps in the adoption of innovations. The conclusions may also serve as a contribution to the implementation of the 2030 Sustainable Development Agenda at the regional level.

### SEMINAR TOWARDS A SUSTAINABLE REGIONAL DEVELOPMENT BASED ON SMART SPECIALISATION , 2-5/12/2015, PIURA, PERU

The EU Smart Specialisation approach was presented in the seminar 'Towards a sustainable regional development based on smart specialisation', organized by the University of Piura (Peru), and the regional government of Piura with the support of Fondecyt (Fondo Nacional de Desarrollo en Ciencia, Tecnología e Innovación).

The S3 Platform delivered several keynote speeches on the Cohesion Policy, Smart Specialisation and the Entrepreneurial discovery process. The Platform animated the debate on the opportunity to adopt S3 for R&I in the region. Our intervention earned the attention of the audience, helping to spread the message of Smart Specialisation beyond the EU boundaries and supporting the momentum that Smart Specialisation policy is gaining internationally. #### FINAL REPORT ON RIS3 IN EASTERN MACEDONIA AND THRACE (REMTH) NOW AVAILABLE

This European Parliament Preparatory Action aimed to facilitate the refinement and implementation of the RIS3 strategy in a region heavily hit by the crisis, to serve as a model for other convergence regions in Greece and Europe, and to serve as a unique test bed for theories on smart specialisation. It was implemented by JRC-IPTS in collaboration with DG REGIO, the Managing Authority of Eastern Macedonia and Thrace, and the Regional Council of Innovation and Entrepreneurship and with the support of selected independent experts. The experience will be used to implement similar support activities in other low income and low growth regions in several European countries. The final report is available [here](#).

#### UPCOMING SCIENCE-FOR-POLICY REPORT: *UNDERSTANDING OF GLOBAL VALUE CHAINS AND THEIR ANALYSIS WITHIN THE CONTEXT OF SMART SPECIALISATION*

Using the case of the Irish pharmaceutical sector, this paper elaborates the foundations and functioning of global [value chains](#), the importance of their analysis within the S3 context, in line with the existing RIS3 framework. A methodological approach to analysing a country's position in GVCs in terms of activities, flows and relationships will be presented. The approach will be illustrated with its application to the Irish pharmaceutical sector. This paper is expected to be published in the beginning of January 2016.
