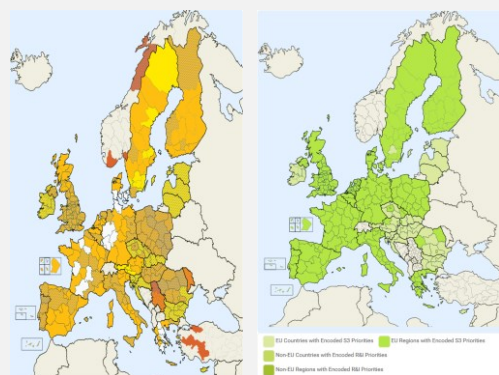

The workshop aims at identifying concrete steps for implementing smart specialisation with a focus on Cultural Heritage as part of the broader area of Cultural and Creative Industries.

Regional and national authorities as well as regional actors (including clusters, businesses, academia, cities, etc.) will get together to discuss joint investment opportunities in specific thematic areas. The workshop is expected to result in agreed collaboration arrangements for the preparation of new partnerships in thematic areas of shared interest and take steps towards the creation of a project investment pipeline, with a specific focus on pilots and demonstrators.

### **INDUSTRIAL MODERNISATION**

Information on the objectives of the S3 Platform on Industrial modernisation (S3P-Industrial Modernisation) is now available, including on how to set up partnerships and on how to accelerate the development of joint investment projects. The key objective of the S3P-Industrial Modernisation will be to provide a basis for supporting **the efforts of EU regions and member states** committed to work together for developing a pipeline of investment projects connected to their RIS3 priority areas related to industrial modernisation.

A **kick-off event of S3P-Industrial Modernisation** will be organised on **16-17 November 2016 in Barcelona**. This working meeting will result in the first batch of partnerships formally joining the Platform as members. At the same time, it will result in agreed working arrangements to prepare partnerships in sub-thematic areas and establish a project investment pipeline, in particular for pilots and demonstrators in the targeted areas. The European Commission is committed to develop support and advisory services to accelerate this project pipeline. ### STAIRWAY TO EXCELLENCE (S2E)

### THE SMART SPECIALISATION CONCEPT OVERTAKES EU BORDERS

The workshop S3BeyondEU was organised in the framework of the Smarter Conference last 29<sup>th</sup> Oct in Seville. The session allowed to showcase the S3 concept implementation in non-EU countries and presented the cases of [Australia](#), [Latin-America](#), and [Ukraine](#). The S3 platform is currently conducting a research study on the evolution of the S3 concept in six Latin American Countries. The [study](#) will suggest how countries and regions of Latin-America and EU can establish cooperation frameworks within Smart Specialisation areas.

### ENHANCED CENTRAL AND EASTERN REGIONAL COOPERATION BOOSTS EUROPEAN BIOECONOMY

At the [European Bioeconomy Congress](#), organised 6-7 October 2016 in Łódź, Poland, efforts to intensify cooperation between regional stakeholders from Central and Eastern Europe were top of the agenda. Alongside the publication of the Łódź Declaration of Bioregions, the Bio-Based Industry Consortium, the Bio-Based Industries Joint Undertaking and eight Polish regions signed a Letter of Intent to develop new bioeconomy partnerships. ### INDUSTRY GLOBAL VALUE CHAINS, CONNECTIVITY AND REGIONAL SMART SPECIALISATION IN EUROPE

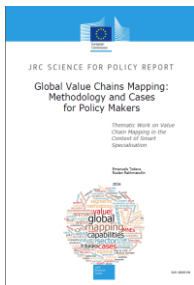

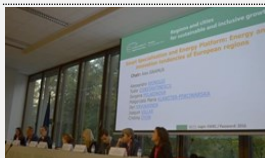
### SMART SPECIALISATION AND SYNERGIES WITH INTERREG, THE CASE OF ENERGY

The Smart Specialisation Platform on Energy (S3PEnergy) presented the paper: [Capitalising on Smart Specialisation and Interreg, the case of energy](#) in the 1st Smarter Conference held in Seville last 29th of September 2016.



The paper suggests that promotion of inter-regional collaboration – during the implementation of RIS3 strategies – can be facilitated by the experience gained by the European Territorial Cooperation instrument (also known as Interreg).

### ENERGY AND INNOVATION TENDENCIES OF EUROPEAN REGION



On the occasion of the European Week of Regions and Cities held in Brussels from 10th to 13th October, the S3PEnergy platform organised the workshop: [Energy and innovation tendencies of European Regions](#).

The workshop highlighted how Smart Specialisation priorities on energy can contribute to the EU Cohesion and Energy policies. Latest activities of the S3PEnergy were also presented including the creation of interregional partnerships on bioenergy, smart-grids, offshore renewables and sustainable construction. Accordingly, the regions of Lapland (FI), Pomorskie (PL), Basque Country and Andalusia (ES) presented their state of play in these topics.
