# S3 Platform 10<sup>th</sup> Peer-review workshop

# 04-05 July in Faro (PT)

The S3 Platform and the Portuguese region of Algarve are organising in the coming days a peer-review workshop with the theme "tourism as a RIS3 priority".

During this workshop, four European regions Algarve (PT), Sicily (IT), Rhône-Alpes (FR) and Kujawsko-Pomorskie (PL) will present their current work on RIS3.

All four of the reviewed regions have tourism as a priority in their RIS3 and this theme will be discussed widely during the peer review. In addition, there will be a thematic discussion on S3 and tourism before the peer review itself, bringing together representatives of industry, research and government.

# RIS3 GUIDE: UPDATE OF ANNEX III

This update of Annex III to the RIS3 Guide is intended to **provide practical tools to policy-makers**, **experts and practitioners** working at both national and regional level on how to approach the process of establishing their RIS3 (research and innovation strategies for smart specialisation) and to assess them, including guidance on the use of the RIS3 assessment wheel.

In particular, a section on "kick-starting your RIS3 process" has been added, which is meant to inspire the very first phase of the RIS3 process and its inclusive character: how to launch it, what to do, whom to consult? It is mainly aimed at suggesting to the regional / national policy-maker how to address the actors of the "quadruple helix" (business, research, public sector, civil society/users) and get their views, opinions and input to the RIS3 development process and its steps.

#### **UNIVERSITIES AND RIS3**

**Universities can be crucial institutions** in the design and implementation of successful RIS3. They have a multi-dimensional role to play, with their research, teaching and community activities all contributing to the transformation of a regional economy through RIS3.

A workshop in February 2013 at the S3 Platform's headquarters in Seville produced a report including key messages, a summary of the discussions and good practice examples from different universities.

The principal "take home" message of the debate was that there was clearly no "one size fit" approach as Europe's regions needed different types of cooperation reflecting their specific contexts. But "common guidelines" could be established that were based on good practices with respect to: established successful cooperation between universities and regional authorities; coordination achieved between national policy and regional policy and funding instruments; and, crucially, how mutual understanding and medium-to-long term cooperation frameworks had been developed.

#### RIS3 IN THE BALTIC SEA REGION

# <u>Get smarter together in the Baltic Sea Region – taking innovation and smart specialisation across borders</u>

On November 7th 2013 in Malmö, Sweden, the S3 Platform together with BSR Stars, StarDust and Vinnova, will organise an event to find cooperation partners and exploit the synergies between the EU Strategy for the Baltic Sea Region and the RIS3s in the same area. The event will offer concrete opportunities to add a cross-border dimension to the development of Smart Specialisation by matching interesting partner regions with the aim at achieving something that they cannot do on their own. Matchmaking will be concentrated around identified common topics, for example Personal Health and Sustainable Cities. On November 6th, results of StarDust will be presented and discussed in relation to how to create strong competitive advantages in the macro-region. The events aim at gathering representatives among innovative companies, clusters, universities, innovation agencies and other actors involved in development and implementation of Smart Specialisation Strategies around the Baltic Sea.

# EuroNanoForum 2013, 18-20 June 2013, Dublin (IE)

EuroNanoForum 2013 focused on the commercialisation of nanotechnologies, exploiting its potential for new applications and taking them further from enabling technologies to end products. It also introduced the industry to new innovations for growth opportunities. Additionally, the conference hosted two workshops which focused on the role of Key Enabling Technologies in the new funding period ('KETs and Horizon2020' and 'KETs-Development and Deployment').

#### 'The Week of Innovative Regions in Europe' (WIRE), 5-7 June 2013, Cork (IE)

This conference series is now recognised as a key element in facilitation of the European regional agenda. The conferences have generally succeeded in bringing together regional, national and European stakeholders including public organisations, policymakers, research communities and enterprises to address, develop and progress key topics of interest to the community. The three-day conference, Week of Innovative Regions Europe IV (WIRE IV), was organised in Cork, Ireland during Ireland's Presidency of the European Union in 2013. The WIRE IV focused on regional aspects relevant to the final stages of the Horizon 2020 design and legislative process and will be positioned primarily as an implementation focussed activity in the context of the Cohesion Policy 2014-2020 and Europe 2020.
