The three regions of Andalucía, Malopolska and Scotland have submitted their Digital Growth Strategy to peers for discussion and feedback.

The event provided regions with knowledge on how to:

- connect RIS3 and Digital Growth Strategies;
- use ICT as an enabling technology, with the specific case of broadband in rural areas;
- better understand ICT as a specialisation and an application area;
- examples of policies to enable ICT diffusion.

EVALUATION GUIDANCE PUBLISHED

The evaluation unit of DG REGIO published a revised version of the Evalsed Guidance on Evaluation our website and a new Sourcebook on Methods and Techniques. The Guidance takes account of the changes in the regulations for Cohesion Policy in the 2014-2020 period. The Sourcebook has new sections on Impact Evaluation - theory based and counterfactual - as well as new material on beneficiary surveys and regression analysis. PUBLICATION OF THE 2013 EU INDUSTRIAL R&D INVESTMENT SCOREBOARD AND 2013 SURVEY ON R&D INVESTMENT BUSINESS TRENDS

The 2013 EU Industrial R&D Investment Scoreboard contains economic and financial data for the world's top 2000 companies ranked by their investments in research and development. The sample consists of 527 companies based in the EU and 1473 companies based elsewhere. An additional sample comprising the top 1000 R&D investing companies based in the EU is included. The 2013 Survey on R&D Investment Business Trends presents the findings of trends in industrial R&D investment. It analyses the 172 responses of mainly large firms from a subsample of 1000 EU-based companies in the 2012 EU Industrial R&D Investment Scoreboard. These companies are responsible for R&D investment worth € 62 billion, constituting around 41% of the total R&D investment by the 1000 EU Scoreboard companies. Please find the report here.

RIS3 GUIDE - UPDATED FAQ PAGE

The <u>FAQ page</u> of the RIS3 Guide section has been updated in the S3 Platform website adding a few more questions and adjusting the text of some of the existing ones following inputs and discussions with policy-makers, experts and Commission services. The RIS3 approach is currently dealt with in the following 12 questions:

- 1. What are the key elements of a "good" smart specialisation strategy?
- 2. How should "priorities" be defined in a RIS3?
- 3. What is the difference between "niche" and "domain" of specialisation?
- 4. How should RIS3 be designed?
- 5. What is the "entrepreneurial discovery process"?
- 6. How are risk, success and failure perceived in the context of RIS3?
- 7. What result/outcome indicators should be considered to monitor and evaluate the strategy?
- 8. Can other sources of funding, besides EU funds, be included in RIS3?
- 9. Can actions or policies that are not linked to EU funds be included in a regional RIS3?
- 10. National or regional RIS3: What is the appropriate administrative/geographical level?
- 11. What is the role of science and business parks in RIS3?
- 12. Does a RIS3 need to contain information on the policy mix for its implementation?
