



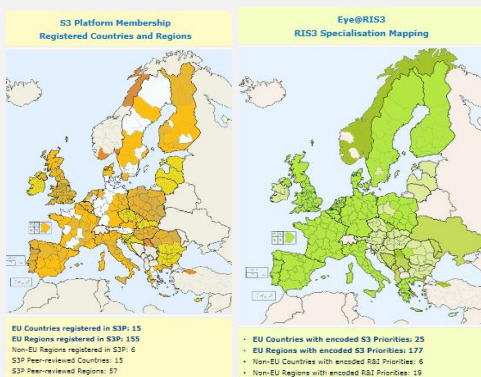

In the frame of the S3P project, joint EARTO-JRC workshop that will take place in Seville on 28th May 2015 to discuss the role of RTOs in smart specialisation (in particular implementation). RTOs are important actors in the innovation chain and can play a key role in the implementation of Smart Specialisation Strategies. The report:

- Identifies global megatrends affecting Industrial transformation;
- Gives an overview of cross-sectoral trends within the ten emerging industries identified by the Observatory (namely Advanced Packaging, Biopharmaceuticals, Blue Growth Industries, Creative Industries, Digital Industries, Environmental Industries, Experience Industries, Logistical Services, Medical Devices, and Mobility Technologies – for each of them a specific trend report is also available)
- Identifies cluster internationalisation trends (separate longer report still to be approved) and trans-regional collaboration paths of European Clusters in Emerging Industries
- Identifies collaboration spaces spanning through emerging industries

SUPPORT TO RIS3 TO THE REGION OF EASTERN MACEDONIA AND THRACE (REMTH) IN GREECE:



2ND PROJECT DEVELOPMENT LAB, 24 JUNE 2015, ALEXANDROUPOLIS

In further supporting the implementation of the RIS3 of the Region of Eastern Macedonia and Thrace, JRC-IPTS and its partners in the region are organising a second Project Development Lab (PDL).

This will take place on the **24th of June at the Hotel Astir Egnatia in Alexandroupolis**, and will build on the outcomes of the four previous Entrepreneurial Discovery Process focus groups (on wine, dairy and meat, tourism and marble/non-metallic minerals) and of the first PDL (DATE May 2015). At this event, selected ideas will be further developed towards concrete implementation and Pilot calls for proposals for the implementation of the RIS3 will be presented by the Special Managing Authority of the Region. 4TH ENTREPRENEURIAL DISCOVERY PROCESS (EDP) FOCUS GROUP EVENT ON MARBLE AND NON-METALLIC MINERALS, 5 MAY 2015, DRAMA

Organised by JRC and its partners in the Greek Region of Eastern Macedonia and Thrace, (REMTh), a fourth **Entrepreneurial Discovery Process (EDP)** focus group event, this time focused on marble and non-metallic minerals took place in Drama on 5 May 2015.
