Research and Technology Organisations (RTOs) have developed in many European countries to assist in the support of local industry, often around specific industrial technologies or sectors. RTOs have important roles to play in smart specialisation. First, many RTOs have capabilities to identify industry needs and technological opportunities as a key input into the entrepreneurial discovery process. Second, RTOs, as increasingly international organisations, can facilitate the access to global knowledge for regional firms through their networks and research collaborations. And third, RTOs often central in the development of particular clusters through their specialisation around core technologies. All these roles involve potential challenges and difficulties as the interests of the RTOs do not necessarily align with the regional needs. The case studies in this report (Spain, Finland, Italy, and the UK) illustrate the variety of RTOs and the complexities of their relationships with regional hosts, but also some of the initiatives to support smart specialisation.
