As consequence of the first findings of the mapping of the arrangements for interregional cooperation in IGJ Regional OPs, where there is a huge interest in RIS3 topics, it is necessary to raise the awareness regarding the practical use of provisions under art. 96.3d CPR as well as the legislative framework for 2021-2027 programming period as laid down in art. 17(3)(d)(v) of the draft Common Provisions Regulation.

This webinar is targeted to Regional Partnerships established under the European Commission – Joint Research Centre [S3 thematic platform](#) as well as to Managing Authorities of Regional Operational Programmes under the IGJ goal.
