





RIS3 approach



► SMART

Identify the region's own strengths and comparative assets



► SPECIALISED

Prioritise research and innovation investment in competitive area



STRATEGIC

Define a shared vision for regional innovation

ANALYSIS: discovery of the socio-economic and R&I engines of regional growth

PROCESS: governance, stakeholder involvement, institutional setting.

VISION/OBJECTIVES: common shared goals.


PRIORITIES: activities/projects/actions to focus on.

POLICY MIX: policy instruments and interactions.


MONITORING: for selection & assessment processes.




Mapping EU regions in terms of H2020 & ESIF (1)




Synergies: Rationale & Concepts

Centralised management	Co-managed with MSs
Annually adjusted WPs	7-year-OP
Research excellence (with individual R&I projects)	Socio-economic development (focusing on R&I capacities)
Not counted for EU State Aid purposes	Counted for EU State Aid purposes

Issues, barriers and policy recommendations for synergies

Quality of Governance

- Instability of governance system
- A long-term strategic plan with a shared vision
- Coordination and communication between main actors
- Accessing the necessary information on a timely manner
- Administrative burden and complicated procedures

Capacity Building

- Lack of capacity (infrastructure, HRs, etc.) for excellent research
- Human capital, incl. researchers and administrative support
- Networking capacities
- Active interaction between academia and business
- Brain drain & Salary differences for researchers

Research & Innovation

- Continuous and sustainable financing
- Different natures/legal framework of funding sources, as well as stateaid and public procurement procedures
- Lack of competences and experience in international collaboration
- Orientation of HEIs and PROs, as well as business-academy collaboration
- Considering ESIF as a guaranteed resource for short-term projects

Proposed policy actions

Quality of Governance

- Better coordinate the current info channels between key stakeholders
- Exploit opportunities provided by EDP
- Independent coordination body
- Learn from good practices & Train key staff

Capacity Building

- Map existing research facilities
- Facilitate accessing to public infrastructure
- Track brain-drain and develop motivational mechanisms for researchers
- Measures to mitigate the researchers remuneration gap

Research & Innovation

- Impact-base evaluation & long-term monitoring for sustainable ecosystem
- Effective public funds and incentives for researchers and SMEs
- Efficient state-aid & Public procurement
- Priority to market-oriented R&I activities
- Align RIS3 and research in where comparative advantages exist

Need for a coordinated approach beyond 2020

Cohesion policy maintains/enhances:

Smarter/Greener/Connected/Social/Closer to Citizens

- Reinforced smart specialisation
- More tailored approach to regions
- Locally-driven development
- More support for innovative companies and market-creating innovations
- More support to interdisciplinary and crosssectors investments

Need for structured collaboration

- Knowledge transfer between key stakeholders
- Common working culture (participation in EDP)
- RIS3 as a coordination tool
- Synergies (not only funding but in a broader scope)

Facilitating mechanisms

- Single rule-book & Simplification
- Extended widening/excellence
- Engaged EU instruments/bodies
- Budget flexibility (5% reallocation)



Post 2020: Mission-oriented R&I and Place-based approach
