Collaboration with NCPs with specialisation by areas/programmes

Information sharing on projects approved & above thresholds Databases, regular ministry reports on H2020 returns by entity/type of projects/areas

Collecting interest domains from experts at the regional level to draft H2020 WP topics

Designing innovative support tools in ESIF OPs promoting the uptake of research results



4/ Networking & learning platform/tools

- holistic approach on ongoing projects
- Timely informed about projects & WP consultations
- Awareness of most active regional actors
- Understand global value chain & regional strengths
- Visibility of research activities at national, regional & cross border → updated database of national & regional clusters
- Awareness of an international strategy (if any) at regional level
- Exploit EDP networking contacts from stakeholder consultations




