## Structured governance systems **are** becoming a priority

- The acceptability of the platform concept is increasing
- Growing interest from regions to join **in**

### But

- A wide variety of interests, local contexts, regional priorities
- Risk of losing momentum
- Risk to lose consistency between thematics





## A multi-level governance systems

- At thematic and at project level to insure consistency
- **Steering committee** at thematic level with a leader and two or three co-leaders from various regions to be representative of EU policy as a whole
- **Project Committee** with one leading region and two co leaders





## Role of steering and project committees

- **Develop a flexible strategic approach for regional cooperation**
- **Develop and agree on a methodology to foster cooperation between regions**
- **Develop, agree and circulate concept notes with specific objectives and criteria for the selection of projects**
- **Develop a communication strategy to promote the concept and attract other candidate regions**







## Coordination with other platforms

- **Develop synergies with the Interreg Europe Policy Learning Platform on Low carbon economy via:**
  - ⇒ **Crossed participation in activities implemented by each Platform**
  - ⇒ **Transfer of knowledge from partners involved in projects cofinanced by the different tools**
  - ⇒ **Regular discussions between the two Steering committees/JS**
