

# **Overlapping S3 priority niches**





## **Thematic S3 Platforms vs. Innovation to Policies**






# Thematic S3 Platforms (TSSPs)



S3 as coordinating mechanism to align efforts...

- Strategic focus: "EDP" of opportunities for co-investment on the S3 priority areas;
- Objective: Support pilot activities towards aligned roadmaps and project pipe-lines leading to coordinated joint investments;
- Governance: joint initiative of pro-active motivated regions (like Vanguard Initiative) supported by thematic policy DGs;
- Composition: motivating potential cooperation partners along value chains!

- 2 of these selected for DG REGIO's Interregional Pilot Actions
- DGs involved: AGRI, REGIO, RTD, JRC
- + 2 new EoIs recently qualified




