

(replacing NWDA)/UK and IWT/Flanders) aims at supporting and further expanding the European Cluster Alliance, and contributing to the development of better cluster policies and practical cluster support tools across Europe.

The work of this group of seven regional and national public innovation agencies and has been focused around six thematic task forces:

- TF#1: Fostering international cluster cooperation;
- TF#2: Channelling RDI funding through excellent clusters;
- TF#3: User-driven excellent clusters;
- TF#4: Supporting cluster marketing and branding;
- TF#5: Evaluating cluster excellence;
- TF#6: Using excellent clusters to address emerging industries (including innovative services).

Additionally 15 European cluster experts the so called "Reflection Group" <a href="http://www.proinno-europe.eu/eca/page/presentation-reflection-group">http://www.proinno-europe.eu/eca/page/presentation-reflection-group</a> have actively participated in the Task Forces and provided inputs and support in developing new policy initiatives via the six task forces. ECA members have also been regularly consulted and asked to provide their views and experiences.

# THE EUROPEAN CLUSTER ALLIANCE (ECA) IS A VOICE FOR POLICY MAKERS INTERESTED IN SUPPORTING CLUSTERS AS PART OF BROADER INNOVATION AND COMPETITIVENESS STRATEGIES.

The ECA has been supported by the European Commission (DG Enterprise) since its launch in 2007 through the CIP/PRO INNO Europe and currently via the TACTICS INNO Net project\* managed by Oseo France and 6 partners among the main Innovation actors in Europe (Vinnova in Sweden, TMG Upper Austria, Manchester Metropolitan University UK, IWT Flanders/ Belgium, Veninn Italy and PAED in Poland).

The ECA is supported by a dedicated Secretariat and shared web platform (PRO INNO Europe). Over the last two years, membership of ECA has grown from some 50 public policy agencies to **almost 120 (with over 250 separate individual policy makers)** and all EU countries are now covered. #### National/Regional Innovation Strategies for Smart Specialisation

Smart specialisation is essential for truly effective research and innovation investments. In the European Commission's proposal for cohesion policy<sup>1</sup> in 2014-2020 it is a precondition for using the European Regional Development Fund (ERDF) in 2014-2020 to support these investments.

National/Regional Research and Innovation Strategies for Smart Specialisation (RIS3 strategies) are integrated, place-based economic transformation agendas that do five important things:

- 1) They focus policy support and investments on key national/regional priorities, challenges and needs for knowledge-based development.
- 2) They build on each country/region's strengths, competitive advantages and potential for excellence.
- 3) They support technological as well as practice-based innovation and aim to stimulate private sector investment.
- 4) They get stakeholders fully involved and encourage innovation and experimentation.
- 5) They are evidence-based and include sound monitoring and evaluation systems.

The RIS3 *ex-ante* conditionality **requires EU Member States and regions to identify the knowledge specialisations** that best fit their innovation potential based on their assets and capabilities.

The strategies should be developed through a process of 'entrepreneurial discovery', i.e. involving key innovation stakeholders, in particular business. Thus, rather than being a strategy imposed from above, smart specialisation involves businesses, research centres, universities and other actors working together to identify a Member State's or region's most promising areas of specialisation that have a potential to provide competitive advantage, but also the weaknesses that hamper innovation there. <sup>2</sup>

Based on this, the national or regional authorities will draw up a **document outlining the proposed strategy for that country or region**, including the **planned Structural Fund investments** in research, technology development and innovation.

This strategy should not only build on and/or aim at **regional scientific excellence** and technology driven innovation, but also support **practice-based innovation**<sup>3</sup> that draws on existing knowledge,

For instance, social and service innovations, action to address social challenges, new business models and demand-side measures such as public procurement.
