Specific objectives

- ❖ To provide **methodological tools to make a Smart Territorial Map of specialization capabilities** of business, industry and research at territory level (region, county, metropolis, city levels), **aligned with target regional S3**
- ❖ To identify, **exchange and disseminate regional good practices**
- ❖ To carry out a **regional strategic thinking process with all relevant stakeholders**, leading to the adoption of **Regional Action Plans focusing on S3 multi-level governance models**
- ❖ To implement and evaluate the impact of Regional Action Plans leading to **improved governance, new projects and updated S3 considering all territory levels**
- ❖ To **deliver policy recommendations** for the mainstreaming of the territorial dimension into S3 and ERDF OPs.

The Irish Context – Building from Scratch

- Ireland's S3 has no noted recognition of regional specificities and no separate smart specialisation strategies at the 3 NUTS II regions (Southern, Eastern & Midlands and Northern & Western).
-
- However, each region has its own individual strengths and competitive advantage where priority areas are of more importance to the economy in that region.
- The Regional and Spatial Strategies (RSES) sets out ambitious frameworks for the 3 regions and provide a timely opportunity to consider and align S3 strategy in Ireland



Why is the SRA or Managing Authority involved in COHES3ION?

- ✓ Provides an opportunity to learn from other EU Regions
- ✓ Identify good practices
- ✓ Import/adapt elements
- ✓ Make improvements in our own policies i.e. Southern RSES



What do SRA want to achieve



- **Focus the region on recognising and building on its smart priorities**
- **A better coordination between innovation support services at regional and local level and the Regional Structures...multi-level governance..**
- **A further refining of smart priorities at regional level, including city and county level, aligned with national S3**
- **Enhanced place-making for enterprise development**
- **A forum to raise awareness around the benefits of a targeted regional S3 aligned with the national priorities**
- **Improved management & monitoring mechanisms at regional level.**

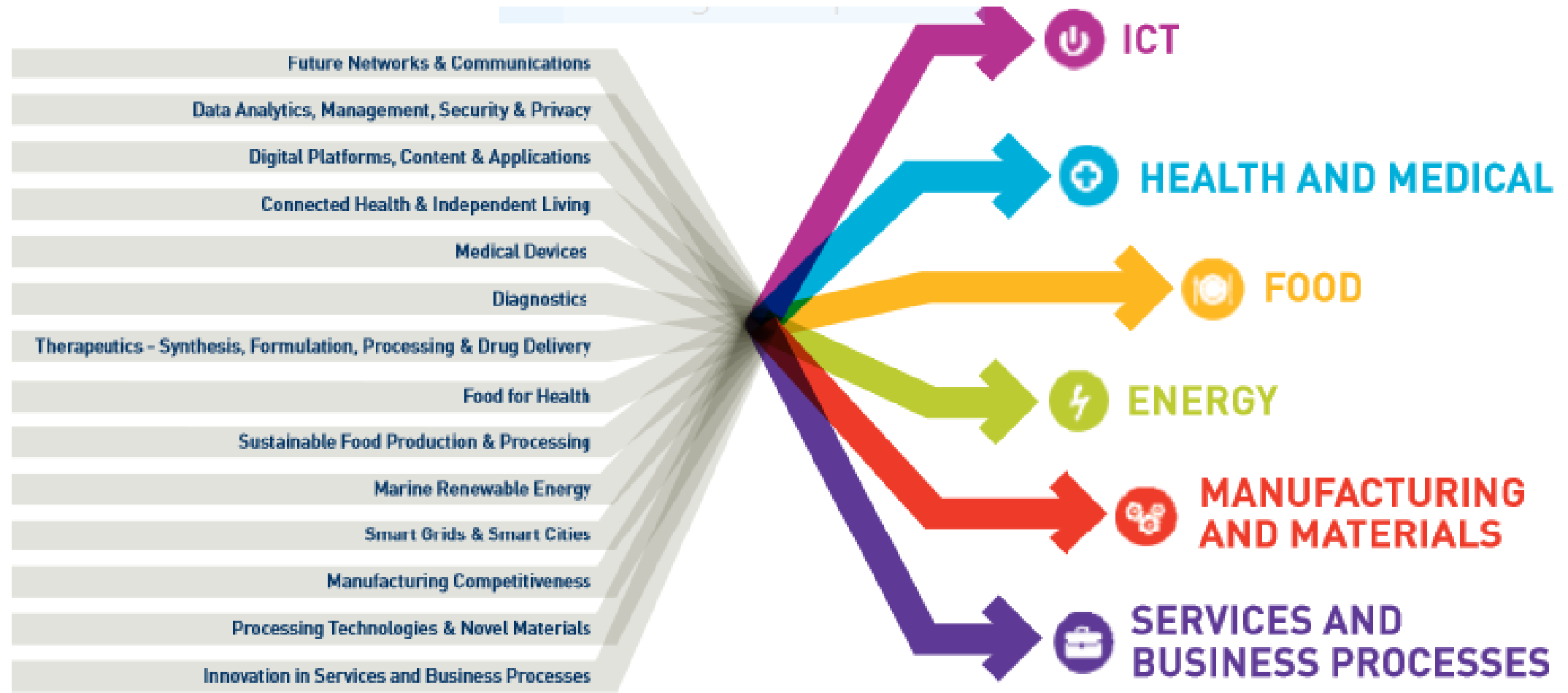


Ireland & ERDF - 14 Priority Areas



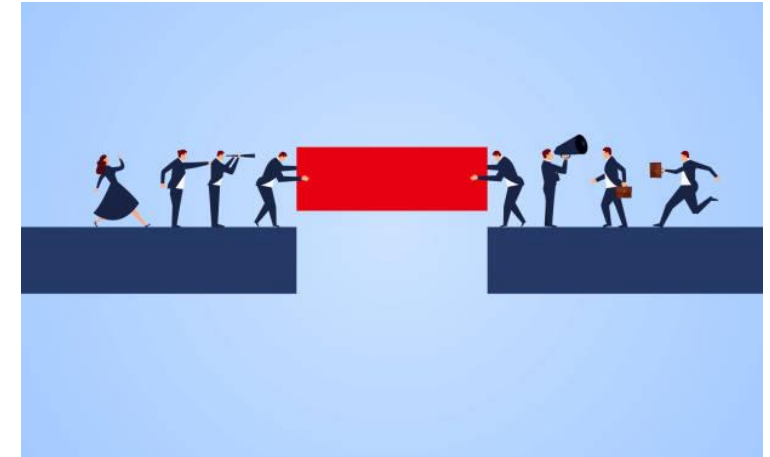

Stagnation Gaps to be addressed

- Post 2021 Ireland needs to address key areas:
 - Governance
 - Entrepreneurial Discovery Process (EDP) and
 - Monitoring and evaluation (M&E).
- Need to develop clear place-based smart priorities which are not just Research priorities
- Support the more strategic approach to clustering
- Build a regional collaborative approach via the three RSES
- Tackle the lack of monitoring and evaluation – develop and report on regional KPI's.



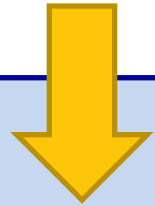
MACRO-ANALYSIS & BENCHMARKING

- Existing R&I initiatives to assess level of innovation and critical mass in key sectors



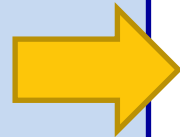
STAKEHOLDER CONSULTATION

- Current and emerging areas of innovation activity “on the ground”
- Deeper understanding of the local needs, framework conditions and perceptions
- Assess readiness and willingness to drive the S3 Entrepreneurial Discovery Process



MAPPING & SWOT ANALYSIS

- Mapping S3 areas with high potential (based on capacity and opportunity)
- Mapping key stakeholder and innovation activities
- SWOT analysis on place-based capabilities, resources, externalities, complementarities



FRAMEWORK & RECOMMENDATIONS

- Prioritisation criteria for selection of S3 areas
- Recommendations on key stakeholder, enablers, and levers – (links with Smart Region)
- Practical framework/toolkit to inform further S3 development
- KPIs for monitoring and evaluation

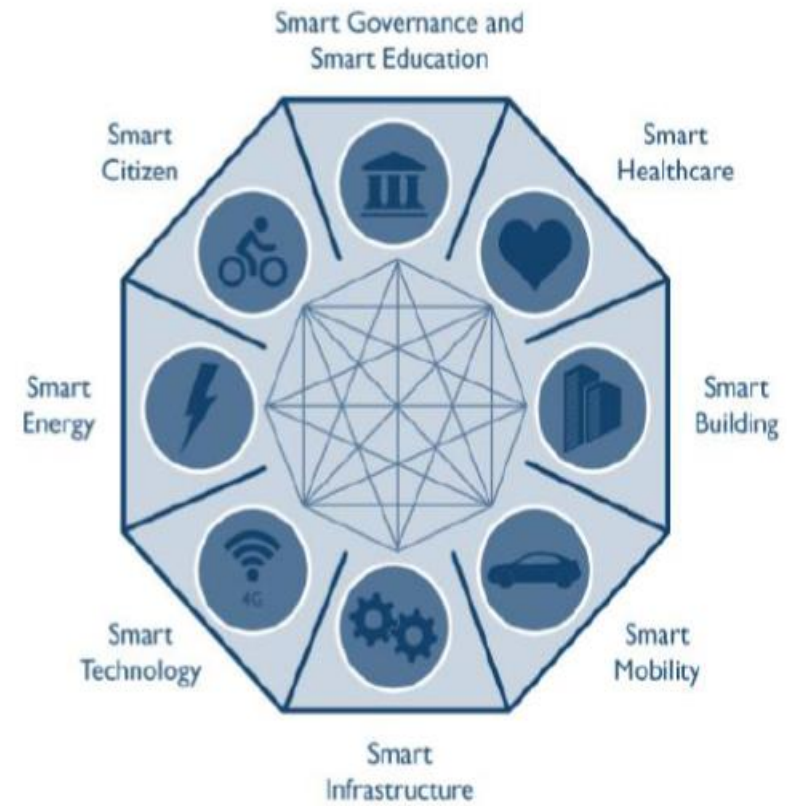
