I. Management report

Please provide the executive summary of the objectives of your partnership

The partnership was launched during the Barcellona event in December 2016 with the aim to support SMEs to digitalise their business and to become more competitive in the global value chain by absorbing the I40 paradigm. The application was officially submitted on the on 4th January 2017 and the Kick of meeting was held in Florence on the 28th February 2017. Then the partnership on I40 and SMEs merged with the partnership co-led by Slovenia and Mazovia. Thanks to the support of the EC services, the Scoping note has been finalised as well as the Mapping Paper. Questionnaires for SMEs and opinion leader questionnaires have been collected to better understand the needs in the territoris and investment project ideas. In addition the partners took part at several meetings/events to promote the partnership. An application for the Interreg Europe – 4th call has been sent in June 2018. The partnership has been represented to all Steering Committee meetings. Interaction with Watify and Reconfirm initiatives has been activated, by taking part to different events during 2017 and 2018. Partners have focus on 3 project investment ideas (1 has been selected as the most relevant one) and draft the Action plan. Interaction with other RIS3 partnership/European projects has been activated during 2019.

The partnership has been successful at applying for the TAF support, so the most important next steps will be together with TAF experts preparing new program for the new perspective, mostly for the new investment projectst and, consequently, to update of the Action plan, the enlargement of the partnership and the formalisation of the investments portfolio.

II. Progress report

Innovative results

Please describe innovative results and achievements that could be attributed to the partnership (specific examples of results vs. objectives)

1. Better knowledge about I40 and its implementation in Europe and in the region involved:
 - 6 Cross-regional collaboration areas have been identified as potential topics of interregional collaboration. These 6 areas are used as starting points to define investment projects and protocols, with the support of ReConfirm. From discussions, detailed operational pilots will be developed.
 - Since the I40 concept is quite broad and includes a new paradigm for business, in addition to new technologies, the first results of the partnership was to map, thanks to the support of Reconfirm, competences, actors and regional policies on I40 in the co-leading regions. This is the basis to define the partnership's action plan.
 - Questionnaire for opinion makers (key actors) has been developed in February 2018 with the support of Reconfirm. This questionnaire aimed at collecting key inputs for the development of the investment portfolio and projects. The questionnaire was completed by industry leaders, cluster and support organisations managers, including financial actors. The sectors covered were: textile, plastics, automotive, milling, aeronautics, ICT, metal, ceramic, and food and beverage. The mapping paper is available .
2. Increase SMEs awareness: Several workshops/events has been arranged to increase awareness on I40 with the involvement of private sectors.
3. The partnership has activated a new way to work through public-private partnership thanks to the active involvement of Regions, RTOs, Innovation Agencies, Business association and companies. This is a key element which contributes to the consolidation and improvement of the existing regional innovation ecosystems at regional and European level.

Tangible short- and medium-term socio-economic impacts achieved or expected (specific examples)

The partnership is still in a preparatory phase for the definition of concrete projects and therefore impact are not yet available.

The partnership has successfully submitted common application on TAF call and won 10 expert day of consulting

During several initiatives arranged, the private sector has been actively involved, included companies. They had actively participated in the activities.

The level of inter-regional co-operation is very good and represents different countries around Europe. It means that it has the potentiality to provide relevant impacts. Some Regions are already active in developing joint european projects and run joint programme (such as MANUNET).
